### Information We Collect

#### Registration Data

When you register for 3bora, we collect the following information:

- Name
- Email address
- Padel skill level (this can be updated later)

## Billing Information

If you make payments through our service, we collect payment information, including your payment method details.

Information we collect for billing purposes:

- Name
- Email address
- Address
- Credit card / Bank account details

We do not store full payment information, as transactions are handled by third-party payment processors.

## Information That We Collect When You Use Our Service

When you use 3bora, we automatically collect:

- Device information (e.g., device type, operating system)
- Log data (e.g., IP address, timestamps, error logs)
- Usage data (e.g., interactions with our platform)

When you using 3bora, we might collect additional information, if provided:

- Preferred courts
- Preferred players
- Preferred timeframe to play

We do **not** collect information via advertising partners, as there are no ads on 3bora.

## How We Use Your Information

We use the collected information to:

- Provide and improve our service
- Facilitate court bookings and match organization
- Communicate with users (e.g., notifications, service updates)
- Process payments
- Ensure platform security and fraud prevention

## Third Parties

We may share your information with:

- Court booking providers (e.g., Playtomic API) to facilitate match scheduling
- Payment processors for secure transactions
- Service providers that help us operate and improve our platform

We do **not** share information with advertising partners.

## Data Security

We implement appropriate security measures to protect your information. However, no method of data transmission or storage is 100% secure.

## Children's Privacy

3bora is intended for users aged 14 and above. We do not knowingly collect personal data from children under 14. If we become aware of such data collection, we will take appropriate steps to delete it.

## Your Rights and Choices
